## KWA's Terms & Conditions

- Kosher World Adventures agrees to provide Accommodations at double occupancy, a private bathroom and shower, and all meals, with wine served twice during the trip. There is an additional fee for Single Occupancy.
- Participation is dependent on:
  1. Signing the health release form
  2. Signing the Terms and Conditions form
  3. Submission of medical travel insurance prior to the trip. For insurance purposes you need extreme sport insurance if you are going rafting or ziplining. even though neither the ziplining or the rafting are extreme in anyway.

### Payment and Cancellation Policy:

- Upon registration, there is a \$1000 deposit.
- The currency of the deposit depends on the trip.
- Completion of payment is done six weeks before the trip.
- We therefore strongly recommend the Purchase of Travel Cancellation Insurance. If you decide not to take out such insurance you are doing so knowing that you run the risk of not receiving a refund.
- In cases of cancellation due to acute health issues or loss, in the immediate family, KWA will credit your paid fees to a different KWA trip.
- In the event of any disagreements/lawsuits, it is agreed that all disagreements will be settled according to Israeli law, under the jurisdiction of the State Of Israel, and at the
